The US ranks poorly on many health indicators...and has been getting worse




Infant Mortality Rate














The ACA: Key Initiatives

- Access to Care
- Coverage for Prevention, Wellness
- Prevention, Public Health Investment
- Improve Quality of Care
- Address Workforce Capacity
- Control Rising Cost of Care

Access to Care and Affordable Coverage

- Medicaid Expansion Jan 1st 2014
 - 133 of FPL
- Health Insurance Exchanges Jan 1st 2014
 - State level or federally operated
 - 133-400% of FPL
 - subsidized
 - Individual and small business together or separate
 - One entry portal for health coverage


Access to Care and Affordable Coverage

- Employee Sponsored Health Coverage
 - Penalties for business that don't offer insurance
 - Tax breaks for smaller business to offer insurance
- Individual Mandate
 - Must have health insurance (few exception) or pay penalty
- Insurance Companies (85% must go to care)
 - Must accept everyone
 - Limit the premiums they charge people

Current MI Medicaid & CHIP Eligibility



Access to Care and Affordable Coverage

- Donut Hole has started to close
- Medicare premiums for 1.2 million
 Michigan seniors will be reduced by as much as \$45/yr.
- Dependent coverage for children up to age
 26

New Insurance Market Rules

- No lifetime limits on dollar value of coverage
- Annual dollar limits as permitted by HHS
- No rescinding coverage absent fraud
- No cost sharing for preventive health services and immunizations
- Ban pre-existing condition exclusions for children
- Ban on excluding children

Prevention & Wellness: Coverage of Services

- Require Medicaid coverage for tobacco cessation services for pregnant women
 - Effective October 1, 2010
- Require qualified health plans to provide at a minimum coverage without cost-sharing for preventive services rated A or B by the U.S.
 Preventive Services Task Force, recommended immunizations, preventive care for infants, children, and adolescents, and additional preventive care and screenings for women

A & B Prevention Services Pertaining to Diabetes Care

- Aspirin use for men and women of certain ages
- Blood pressure screening (adults)
- Cholesterol screening for adults of certain ages or at a higher risk
- Type 2 Diabetes screening (sustained blood pressure 135/80)

A & B Prevention Services Pertaining to Diabetes Care Con't

- Obesity screening and counseling for all adults and children (age 6+)
- Tobacco use screening for all adults and cessation interventions for tobacco users
- Healthy Diet Counseling
- Depression screening

Prevention & Wellness: Coverage of Services

- All Immunizations Recommend by Advisory Committee on Immunization Practices (ACIP)
 - Influenza Vaccine
 - Pneumococcal Vaccine
 - Just to highlight a few

Prevention & Wellness: Coverage of Services

- Authorize Medicare coverage of personalized prevention plan (annually), effective Jan 1, 2011
 - Comprehensive health risk assessment,
 - Referrals to community-based lifestyle interventions
 - Risk factor list and screening schedule (www.healtyamericans.org)
- Provide incentives to Medicare and Medicaid beneficiaries to complete behavior modification programs including: Optional, effective Jan 1, 2011
 - Diabetes prevention and management
 - Lowering weight, cholesterol, and blood pressure

Prevention & Wellness Initiatives

- National Prevention, Health Promotion and Public Health Council will coordinate federal prevention, wellness, and public health activities and develop strategy to improve nation's health
 - Creates a Prevention and Public Health Fund to expand and sustain funding for prevention and public health programs
 - Funded at \$500 million in 2010 and growing to \$2 billion in 2015 and thereafter
 - Grant money available for states

Prevention & Wellness Initiatives

- Nutrition Labeling in Chain Restaurants (20+ locations)
- Childhood Obesity Demonstration Project
- Better Diabetes Care
 - National Diabetes Report Card
 - Vital statistics collection
 - Study of appropriate level of diabetes medical education
- National Diabetes Prevention Program (DPP) - authorized
