

DPAC Full Membership Meeting Minutes October 5th, 2009

Micki Juip and Peter Dews, DPAC Co-Chairs, welcomed new and returning members to the full member meeting and reviewed the agenda. They thanked Merck & Co, Inc and Novo Nordisk for sponsorship of the meeting.

Diabetes Group Visit Project

A presentation was provided by Paul Dake, MD of the McLaren Family Medicine Residency Center. A grant was obtained with the help of the Greater Flint Health Coalition to implement the group visit model within the Greater Flint area. An explanation on the group visit logistics, documentation tools, (including the Diabetes Group Visit Questionnaire, Progress Note, McLaren Diabetes Care Plan, My Diabetes Action Plan, etc) and Diabetes Registry Tables and Reports was discussed. These forms were provided in the participant packets. According to Dr. Dake, the data and the model are used to coordinate the sharing of best practices and research studies.

Diabetes Prevention and Control Program (DPCP) Update

Dan Diepenhorst, MDCH Diabetes and Kidney Disease Unit, Manager, announced changes in DPAC support staff and provided an update on the State budget. A summary was given on state cuts, including a large reduction of National Kidney Foundation of Michigan funding and a loss of funding to 14 programs including the Diabetes Outreach Networks (DONs). Dan highlighted the new DPAC website and Michigan Diabetes Action Plan. Also discussed were the new "Michigan Diabetes Prevention Course", the Network Analysis Report, Improving Performance in Practice Program (IPIP) Learning Collaborative and a reminder of the upcoming Diabetes Self-Management Training Program Coordinators Annual Meeting.

Patient Centered Medical Home

Dana Watt, Michigan Primary Care Consortium (MPCC), presented on the state of current primary care system, the basics of primary care, the Patient Centered Medical Home (PCMH) model, transformation objectives, and detailed information on IPIP. DPAC Board Update

Micki Juip and Peter Dews thanked current Board members for their contributions to DPAC. They also highlighted the new DPAC website and Michigan Diabetes Action Plan. Since many DPAC updates had already been discussed, a more comprehensive Board update will be held at the next Full DPAC Membership Meeting.

Economic Cost of Diabetes and Impacts on Consumer Behavior

William Herman MD, MPH, Michigan Diabetes Research and Training Center, University of Michigan presented on Value-Based Benefit Design and UM Michigan Healthy Communities Initiative: Focus on Diabetes. He provided information on the basics of value-based benefit design, the outcomes of the Asheville Project, as well as the intervention and outcomes of the UM pilot project, UM Healthy Communities Initiative: Focus on Diabetes. Results included targeted co-pay reductions increased uptake on all medications, including an increased adherence for ACE/ARBs and statins.

DPAC Workgroups and Membership Committee Reports

The workgroups met from 1:00 - 2:30, following lunch. Each workgroup reported out on their current activities and/or their priorities for the coming year. The highlights include:

- Membership Another new member orientation was provided prior to this meeting with ten new members. We are providing follow-up with all new members. A letter was sent out to lapsed DPAC members that have resulted in an up to date membership list. Please continue to make nominations with special attention to the areas that do not currently have representation on DPAC including people from non medical businesses and managed care.
- Training and Education Programs The workgroup completed the review and selection of materials to be disseminated on oral health and diabetes and pregnancy and diabetes. A list of potential recipients to whom we will make a concerted contact is currently being compiled based on group members' contacts. The selected materials have been posted on both the MDCH and DPAC webpage. They are now considering how to evaluate our process for the distribution of materials.
- Communications and Public Awareness The workgroup has been developed key messages to for general audiences, reviewing existing materials and discussion potential means of dissemination of these messages. Some of their accomplishments include their work on the DPAC display, website, four newsletters, and two articles on economic burden, an area they will still continue to focus on.
- Prevention The workgroup has been working on pre diabetes articles, fact sheets, and is working with the Communication Workgroup in regards to World Diabetes Day (November 14th) activities such as the Governor Proclamation and emails about World Diabetes Day to DPAC membership.
- Data, Research and Evaluation The DaRE workgroup contributed to the development of the two Diabetes Fact Sheets, DaRE and Full DPAC membership surveys, wrote three translation briefs, and summarized current published cost of diabetes information. Will continue to write translation briefs, focus on dissemination of currently products, and review professional standards.
- Advocacy and Public Policy Members are encouraged to participate in Diabetes and Kidney Disease Day on April 28, 2010. It is important to have a strong presence, engage new partners (including businesses and Joining People with Diabetes) and enhance advocacy efforts. Upcoming efforts include an advocacy training webinar (before Advocacy Day) and to work with the Communication Workgroup on public awareness on Facebook and Twitter. Past activities included the 2009 Diabetes and Kidney Disease Day, the DPAC position statement on Medicare Reimbursement for CDEs, and the Diabetes Care Management Report.
