Abstract:

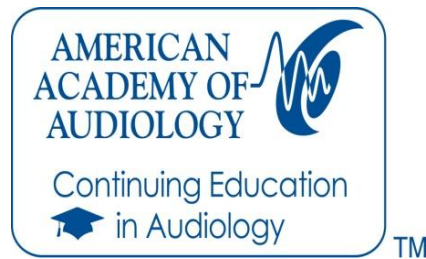
